



- College Cooperative Education (Co-op) Program: 6-month program, offered January-June or July-December







FHLBank Boston Membership by Type





POSITION REQUIREMENTS

- Cash checks for customers and non-customers.
- Process and properly record the sale of monetary instruments (i.e. official bank checks)
- Process foreign currency purchases and sales.
- Redeem savings bonds.
- Properly file all government-mandated reports related to large cash transactions and the sale of all monetary instruments.
- Process various types of loan payments and credit card cash advances.
- Assist with providing customers with access to safe deposit area.

Step 1



SUBMIT YOUR PIC APPLICATION

- Begin and review your application.
- If additional support is needed, reach out to your PIC Career Specialist, who can help with your resume and application.
- · Confirm your availability for a summer job.
- Begin drafting your application short answers
- · Submit the final version of your resume.

Important: Some healthcare employers will require additional materials after submission:

- Letter of recommendation from 1-2 teachers
- 2. Recent report card/school transcript
- 3. Essay/Personal statement

PREPARE YOUR HIRING DOCUMENTS

U.S. Citizens: Massachusetts ID, Unexpired U.S. Passport, or Student ID with Picture Non-U.S. Citizens: Green card, I-94, or EAC Card

- Valid Social Security Card
- If resume is submitted via Google Docs, be sure to share with your PIC Career Specialist.

Important: If you do not have these documents, contact your PIC Career Specialist immediately.



ACE YOUR INTERVIEW

- · Confirm your availability and set a reminder for the date and time of your in-person or virtual interview.
- Reach out to your PIC Career Specialist to help you prepare for your interview
- Send a thank-you email 24-48 hours following the end of your interview.
- · Prepare to hear from your PIC Career Specialists via email or phone. Don't forget to activate and check your voicemail.

Important: Contact your PIC Career Specialist if you cannot attend your interview or have any technical issues.

Remember: No call/no show = No rescheduled interview


